There are two sets of eligibility criteria, which is based on an employee's first WRS participation with any employer: Before July 1, 2011: at least 12 months and at least 600 hours, or on or After July 1, 2011: At least 12 months and at least 1200 hours. Will need to back track and submit reports and payments to get current. Reminder liquor licenses need approval at next month's meeting. Need for a Deputy Clerk to cover meetings when Clerk can't be present.
